Prior to joining ArentFox Schiff, James served as an attorney-advisor at US Customs and Border Protection (CBP) from 2014 to 2021. During his tenure at CBP, he advised on legal and policy issues involving the US-Mexico-Canada Agreement (USMCA), including issues relating to duty preference, classification, entry procedures, recordkeeping, prior disclosures, penalties, duty deferral, and customs and labor enforcement. James played a key role in developing CBPâ??'s USMCA-related regulations and policies, including those related to the automotive rules of origin, as well as other guidance and technical materials.

Before his USMCA work, James served in the Valuation & Special Programs and Border Security Regulations branches within CBPâ??'s Regulations and Rulings, where he drafted binding rulings and advised on a wide range of customs and trade issues, including on valuation, classification, free trade agreements, special trade programs, country of origin, and issues arising out of US Court of International Trade litigation.

Earlier in his career, James practiced at a boutique law firm specializing in transportation law and representing freight forwarders and motor carriers. James was an editor on the *George Mason Law Review* and a law clerk for the US Attorneyâ?'s Office for the Eastern District of Virginia while attending law school.
