Client Work

- Won a *Daubert* motion to bar plaintiff's experts from testifying in automotive product liability case, due to their testimonies' lack of scientific credibility. Motion also requested summary judgment, which was granted and ended the case against Jonathan's client.
- Obtained dismissal for major automotive manufacturer from a contribution action brought by a third party plaintiff in multi-party litigation. The court's granting of the motion to sever leveraged a dismissal with prejudice and without settlement.
- Won summary judgment on behalf of major automotive client where plaintiff's theory of product defect was one of first impression.
- Successful in minimizing automotive client's exposure to repeated asbestos law suits.
- Won partial summary judgment on *res judicata* grounds on behalf of construction contractor after plaintiff collected damages from an arbitration panel.
